

This day came again the said complainant, by Anthony A. Slakis, Esq., of the firm of Slakis & Spence, her solicitors, and it appearing to the Court that the said defendant has had due notice of the pendency of this suit by publication for four (4) consecutive weeks in the Chicago Daily Law Bulletin, a secular newspaper published in the City of Chicago, County of Cook and State of Illinois, according to the Statute in such case made and provided, that the default of said defendant was taken and the complainant's Bill of Complaint herein taken as confessed by said defendant, the Court being fully advised of the fact that said Joseph Becker, is an insane person, and, therefore, appointed Samuel B. Falk, guardian ad litem of said defendant, Joseph Becker, insane, and the Court finds that the law has been complied with in this case in his regard, and that said defendant's rights have been fully observed and protect. ed; and the said defendant appearing in Court by Samuel B. Falk, his guardian ad litem, and this cause coming on to be heard upon the Bill of Complaint, the answer of said guardian ad litem and replication.

And the Court having heard the testimony of the witnesses taken in open Court, in support of said Bill of Complaint (a certificate of which evidence is filed herein) and now being fully advised in the premises doth find that it has jurisdiction of the parties hereto and the subject matter hereof; that the complainant

an actual resident of Cook County, and has been a resident of the State of Illinois for over one (1) whole year next before the filing of the Bill of Complaint herein, that the parties hereto were lawfully joined in marriage on the 11th day of June, A. D. 1910, at Chicago, Illinois; that subsequent to their intermarriage the defendant has been guilty of habitual drunkeness for the space of two successive years prior to the filing of the Bill in this cause as charged in the Complainant's Bill of Complaint.

And the Court further finds that the following described real estate, to-wit:-

Lots 35 and 36 in Block 2 in Bonds' Subdivision of the North 60 acres of the North East Quarter (N.E.1) Subdivision of Section 23, Township 37 North, Range 13, East of the Third Principal Meridian, in Cook County, Illinois;

It is further ordered, adjudged and decreed that the complainant have the sole care, custody, and education of the children:

It is further ordered, adjudged, and decreed that Martin J. Isaacs, Master-in-Chancery of said Court shall be and he hereby is authorized and directed to execute a conveyance of all the right, title, and interest, of Joseph Becker, defendant, herein, in and to the real estate hereinabove described, to Plizabeth Becker, complainant herein, vesting the title thereto in Elizabeth Becker, as her sole property, and vesting sole and exclusive ownership therein in Elizabeth Becker, complainant herein, free and clear of homestead, dower, or rights or claims of defendant, Joseph Becker, in and to the aforesaid real estate.

It is further ordered, adjudged, and decreed that solicitor's fees and alimony for the complainant, for the support of herself and said children, shall be and the same is hereby reserved, and the Court further reserves the right to enter such other or further orders herein to vest such title, as aforesaid, in complainant, Elizabeth Becker, in the event it should appear necessary to do so at any time hereafter.



TO THE HONORABLE JUDGES OF THE SUPERIOR COURT OF COOK COUNTY, IN THE STATE OF ILLINOIS, IN CHANCERY SITTING:

Your oratrix ELIZABETH BECKER, of the City of Chicago, County of Cook and State of Illinois, respectfully represents unto your Honors that she is an actual resident of said County of Cook and that she is now and for more than one year last past, continuously immediately preceding the filing of this Bill of Complaint, has been an actual resident of the County of Cook and State of Illinois; that on or about the 11th day of June, A. D. 1910, at Chicago, Illinois, she was lawfully married to JOSEPH BECKER, the defendant hereinafter named, and from that time until on or about to-wit: the 8th day of September, A. D. 1925, (being the day following Labor Day) she lived with him as his wife, and during all that time faithfully performed all her duties and obligations as his wife, and bore with her husband's faults and errors and strove to make their home and family comfortable and happy.

Your oratrix further represents unto your Honors that as the issue of said marriage she had by him, the said defendant, the following named children:

Erwin Becker, now 14 years of age Ruth Becker, now 11 years of age Bernile Becker, now 8 years of age, and Mildred Becker, now 4 years of age,

and that all of said children are residing with your oratrix; that in consequence of the conduct and habits as hereinafter more specifically set out, the said JOSEPH BECKER, is wholly unfit to have

the care, custody and education of said children.

Your oratrix further represents and charges that the said JOSEPH BECKER, has been guilty of extreme and repeated cruelty towards your oratrix; that he on divers days and times after said marriage has beaten, struck, choked and otherwise cruelly abused and ill-treated your oratrix, and has used vile and opprobrious language toward her and the said children, and has at divers times threatened the life of your oratrix, so that her life has been rendered miserable; and your oratrix shows and charges that on or about to-wit: in the month of September, A. D. 1924, while your oratrix was walking through a prairie with her baby in her arms, the said defendant came up to her and struck her most severely with his fists, causing the baby to fall out of her arms; that afterward on or about to-wit: September 8th, 1925, (being the day following Labor Day), the said defendant beat and struck your oratrix with his fists over her face and head, for which act of cruelty your oratrix had the said defendant arrested and the said defendant was sent to the County Jail for wife beating; and that afterwards on or about to-wit: the 18th day of September, A. D. 1925, the said defendant returned from jail and broke into the house and then and there broke windows, dishes and other articles of household furniture and also kicked your oratrix in the hip; and again the said defendant was arrested and kept in the Psychopathic Hospital until October 1st, 1925, when the said defendant was adjudged insane by the County Court of Cook County, Illinois, and sent to the Kankakee, State Hospital, Kankakee, Illinois; that ever since on or about towit: October 1st, 1925, the said defendant has been and or insane patient of the Kankakee State Hospital, Kankakee, Illinois; and that the said defendant on or about to-wit: in the spring of the year 1927, escaped from said Kankakee State Hospital, and that his whereabouts are unknown up to the present time.

Your oratrix further shows and charges that for the space

plaint, the said defendant has been guilty of habitual drunkeness; that drunkeness was almost a daily occurence with the said defendant, and that the said defendant continued to allow himself to become so drunk and intoxicated notwithstanding the remonstrances of your oratrix and her solicitations that he change his manner of life; and that while he is thus intoxicated, he is very quarrelsome and ill-treats your oratrix and said children, using abusive language and opprobrious epithets, rendering your oratrix's life miserable.





BE IT REMEMBERED, that the above entitled cause came on for hearing on the 12th day of January, A.D. 1928, before the Honorable JOHN J. ELIZABETH BECKER

the complainant, being first duly sworn, was examined and testified on her own behalf as follows:

BY MR. SLAKIS:

Q What is your name? A Elizabeth Becker.

Q Where do you live? A 11208 South Sawyer Avenue.

Q Chicago?

A Yes, sir.

Q How long have you lived continuously in Cook County, State of Illinois, before you filed this suit for divorce?

A Thirty-five years.

Q When and where were you married to the defendant Joseph

Becker? A I was married June 11th, 1910.

THE COURT: Where? A Cook County.

MR. SLAKIS: Chicago?

A Yes, sir.

Q When did you separate? A September 8th, 1925.

How many children born of this marriage? A Four.

Q Are they all living with you? A Yes.

Becker? A He is fourteen years,

Q Ruth Becker?

A She is eleven.

Q Bernelie Becker? A She is nine.

Q Mildred Becker? A She is four.

Q How did you treat your husband while you lived with him?

A I treated him good. I done everything a wife could be expected to do.

Q How did your husband treat you? A Bad. He was cruel and drunk.

Q How often did he get drunk? A At least twice a week.

Q For how long a period did that go on, prior to your separation?

- A Oh, for more than two years.
- Q Were you employed while you were living with him?
 - A Almost all the time.
- Q Now, the property described in your bill of divorce, is located at 11208 South Sawyer Avenue, and you live on that property with your children don't you?
- A Yes. The near their home? The Arms of the Posts I was . Q How did you acquire the title to that property?

- Q What is your name? A Mrs. Louise Allen.
- Q Where do you live, Mrs. Allen? A 10721 South Troy Avenue.
- Q Do you know Mr and Mrs. Becker? A Yes, for eleven years.
- Q Did you live near their home? A For six years I was their neighbor.
- Q How did Mrs. Becker treat her husband while they lived together?

 A She always worked and did her housework, and took care of the children,
- Q Did you ever see Mr. Becker intoxicated?
 - A All the time I seen him intoxicated.
- Q That was about eleven years? A For six years, while I was their neighbor.
 - Q For six years how often did you see him drunk?
- A More than once a week. At night when he came home he always had some in him.
- Q Did you ever see him hit his wife? A Yes. The day the baby was born he hit her, because she took ten dollars from him to give the doctor. He always abused her.

(WITNESS EXCUSED)

ANNETTE TILTMAN

called as a witness on behalf of complainant, being first duly sworn, was examined and testified as follows:

BY MR. SLAKIS:

- Q What is your name? A Annette Tiltman.
- Q Where do you live? A 10810 Utica Street.

- Q Did you know Mr and Mrs. Becker while they lived together? A Yes, sir.
- Q How did Mr. Becker behave himself with reference to sobriety? A He was drinking and he cursed her and abused her and the children.
 - Q For how long a time did that go on?

A I saw it three times when I was visiting in their neighborhood.

THE COURT: How often did you see him drunk?

A Why three times.

Q Is that all? A I was far away from them, I just went to visit them. I lived two miles away.

MR. SLAKIS: How long have you known him?

A About nine years.

THE COURT: You only saw him drunk three times?

A I did not live close to them. I just went to visit them but he was in an awful condition.


